MILANO WITH FIVE RINGS 2019: IOC CONGRESS AND FINAL “SPORT MOVIES & TV”



121th Session and XII Olympic Congress in Copenhagen (Denmark) in 2009

Milan (Italy) will be the sole Candidate City for host the 132nd IOC Session in September 2019. The International Olympic Committee (IOC) – that will officially assign the event during the Session held in Lima (Peru) on September 17th – will appoint the Evaluation Commission that will visit Milano on May 23rd and 24th. The candidature of Milano (*other cities were Brussels, Krakow, Budapest, Istanbul, New Delhi*), has been wished by the Italian NOC President Dr Giovanni Malagò in agreement with the Mayor of Milano Dr Beppe Sala as well as with the Governor of Region Lombardia On. Roberto Maroni. The IOC General Assembly involves the participation of IOC stakeholders including the IOC Members and Commission’s Members, Presidents and Secretaries of International Sports Federations, representatives of the Candidate Cities that will host the next Olympic Games, among 400 journalists coming from all over the world. During the IOC Session 2019 - besides the selection of the city that will host the 2026 Summer Olympic Games – will be elected new IOC Member, approved any reports prepared by the Presidents of Commissions, any changes to be made to the Olympic Charter, etc. The “*MiCo - Milano Congressi*” Europe’s largest center that can accommodate up to 18.000 people, is the venue that will host the event. The “Opening Ceremony” will be held at the “*Teatro alla Scala*”.

The Executive Committee of **FICTS - Federation Internationale Cinema Television Sportifs** (recognized by the International Olympic Committee for which it promotes the values of sport through footages in its 116 Member Countries), presided by **Prof. Franco Ascani**, Member of IOC Culture and Olympic Heritage Commission, has anticipated to September (during the same date of the IOC Session) the World Final of 16 Festivals (in the 5 Continents) of the “World FICTS Challenge” Worldwide Championship of Cinema, Television and Sport Culture already fixed in Milano in the middle of November.

“**Sport Movies & Tv 2019**”: seven days of Cinema, Television and Sport Culture, a privileged meeting place for 5000/6000 operators and industry experts from around the world including Networks, media, broadcastings, houses of productions, producers, directors, filmmakers, Olympic Committees, advertising and integrated communication agencies, that will show the whole universe of cinema and sport television through spot, reportages, fiction, cartoon, etc. in 8 competitive Sections: 1) *Olympic Games*; 2) *Documentary*; 3) *Tv Shows - New Technology*; 4) *Sport & Society*; 5) *Sport & Disability*; 6) *Movies*; 7) *Sport Adverts*; 8) *Movies & Tv Football*. The Festival, characterized by a wide international participation (journalists, sports champions and Sports Institutions, etc.) will be articulated in **Projections** (with worldwide and European premieres), **Meetings**, **Workshop**, **Exhibitions**, **Press Conference**, **Awards of international guests**, **Side Events**.

The 2017 edition of “Sport Movies & Tv” will be held in **Milano** from **November 15th to 20th**. Registration are open. The **Official Rules** and the **Entry Form** are available on <http://www.sportmoviestv.com/en/2016/12/15/sport-movies-tv-final-milano-from-15-to-20-november-2017/>.
